Robert Love serves as the Group Director of Asset Based Lending (ABL) for Signature Bank. When he joined the Bank in 2013, Bob was tasked with launching the Signature Bank Asset Based Lending Platform, which includes recruiting, origination, operations, and the development of the ABL credit policy. This year, the ABL group will be celebrating its 10-year anniversary.




